would be here today, still working in plumbing and being honored with the opportunity of having a leadership role in a great organization like the Plumbing Manufacturers Institute.

As I begin my term as PMI President, I think back to something someone said to me long ago: "You are what you were when..." The statement refers to changing the perceptions that one might have about who or what you are, depending upon when and in what context they knew you. That perception could be good or bad, right or wrong! It's all a perspective of a particular viewpoint at a point in time.

In my view, the PMI membership and Board of Directors know who and what PMI is. We also know who and what we are not. The key is getting the word out, so that others can know exactly who we are and what we stand for. As we embark on this new decade, my aim is to expand PMI during my term. PMI, of course, will continue to be proactive in pursuing codes, standards and legislative policy that make sense for the industry. We will also seek ways to grow PMI and our influence, not only to a broader world but within ourselves. We will continue to build the organization so that those on the outside looking in, agree that PMI is a credible voice for the industry and an organization that they want and need to be affiliated with. As part of our outbound message to others, an organizational name change is in the works. Very soon we will bid a fond farewell to the "Institute" and move forward as Plumbing Manufacturers "International," with a new look that better reflects what we are all about. At "home" we will look for new ways to expand the value and benefits within the member companies beyond the "usual suspects" who regularly participate in PMI activities. We put great value on the regular attendance of this loyal group, but we also need to reach out to other individuals and departments within member companies to get them to more actively participate in the Plumbing Manufacturers Institute.

As part of our strategy, PMI has become more involved in Government Affairs activities. In recent years, in addition to our Federal presence (greatly enhanced last year with the addition of Waterman & Associates), we have added state lobbyists, to further expand our role in the political area. While some would argue it is an uphill battle and question the value of the effort, if you don't want to get steamrolled, you need to have a seat at the table and stake your claim as the

"go-to expert " for our industry.

We will continue to seek participation of non-member companies in the plumbing industry. We will strengthen our effectiveness by joining forces with groups representing other disciplines within adjacent industries, and reach out to distributors, contractors and suppliers as well.

We will continue to leverage our international relationships for mutual benefit: the Bathroom Manufacturers Association (BMA) in Great Britain, **CEIR** (Valve Association) in Europe and, of course, one of our longest relationships, with our friends to the north at the Canadian Institute of Plumbing and Heating (CIPH). We will expand those relationships to seek ways to synergize and share best practices for the common good of our industry. We will offer more services to the members to help them address the continuing green movement.

I would also like to initiate the new practice of expanding PMI visibility and reach through community service opportunities in the cities that host our semi-annual meetings. You will hear more about this in the coming weeks.

Many opportunities and challenges lie ahead. My hope is that at this time next year, we will be well on our way to an expanded PMI. We will be able to look back and say with positive enthusiasm: "PMI is not what they were when!"

One of the biggest changes in PMI since its restructuring in 1998 is the current and effective, inclusive nature of our initiatives. Once known as the "Just Say 'No' Bunch," today PMI is

leading the charge on a number of fronts. PMI has become the voice and the choice for our industry. As we enter another new decade, we continue to solidify our position as the go-to source for information and action.

We are proactively promoting legislation that supports water efficiency and harmonization of product content requirements. We have successfully partnered with groups, both domestic and international, that share our vision and we have reached out to seemingly disparate groups to find areas of common ground. Appropriately, the attitude of the PMI Board of Directors and our membership is that it can no longer be a matter of "us and them." To maximize our progress it must be simply "us," working together to achieve our mutual goals.

The 2010 Spring Meeting is being built around these successes. Our theme, "Expanding the Value," speaks to the concerted efforts we have in-theworks for reaching out to important new allies, adding new prospective product group members to our roster, inviting more participation by representatives from within current, member companies and our mission to enhance the international value and knowledge of our membership.

We will hear updates from around our industry from our invited guests. (And by the way, the historic and prestigious meeting venue, San Diego's Hotel Del Coronado, once again fulfills the directives of the Board and our members by being located within an hour of an airport and with rates under \$200 per night!)

Another significant change over the years has been the increasingly strategic use of the talented PMI Board of Directors. In the early years, much of the efforts were, rightfully, focused on creating the structure and setting the direction of the "new" PMI. While the management of the organization's operations, staff and finances fall squarely on my shoulders, approvals for policies and strategies are the responsibility of the PMI Board of Directors.

With the structure solidly in place, the dissatisfaction of the membership and the uncertainty of PMI's chances for survival are distant memories. With the rotation of the Board, the membership at large and even our PMI staff, not many individuals currently active in PMI realize how far we have come. Not many people remember that the PMI meetings were set around not one, but two golf tournaments in the three-day conference. Work on industry issues occurred basically twice per year at the conferences (in the fall and the winter/spring) with few committee meetings in between. There was no "PMI News," "Tech Talk," conference calls or email blasts to bond members and keep them apprised of

progress between conferences. Government affairs were monitored only on the national level and not state-by-state as they are today. Action by the association was, at best, slow and was typically reactive, not proactive. Dues and spending increased annually and "special assessments" were common.

Today our successes, financial stability, the efficiency of our meetings and industry reputation are "givens." With the influx of new leaders and members, the question becomes, "What have you done for us lately?" While the progress we have made is worthy of noting, as one not content to live in the past or rest on my laurels, the constant push suits me just fine! I've earned a reputation as being responsible for taking the "fun" out of PMI meetings. As much as I hate the sound of that, I am pleased at the progress we make on our issues by working on them between meetings and using the conferences as the reporting mechanism. Our meeting templates have been copied by other organizations looking for "best practices."

Expect great things as we enter another decade. Keep those ideas, comments, criticisms and challenges coming. PMI is your organization. We are up to the challenge!

### Global Body Promotes the Importance of Plumbing

Members of the Plumbing Manufacturers Institute will be only too aware of the important role which their products play in today's society. Plumbing products, professionally installed, are (or should be) at the heart of every building in every village, town and city. In developed countries like the USA, good plumbing with good products have contributed to good public health for more than a century. Today, and increasingly in the future, as the environment and green issues become higher on most peoples' agendas, it will also be the plumbing industry which has most to offer whether through energy efficiency and the use of renewable sources of energy, or through water savings and reuse. In short, plumbing is important and that summarises the message which I am keen to promote in my three-year term as Chairman of the World Plumbing Council (WPC).

WPC was established in 1990 following a highly successful World Plumbing Conference in London, England. At that time, one of the main goals was for plumbing industry people to meet at a similar conference somewhere in the world at least every three years. While, six triennial conferences later, that remains a goal (and the frequency will increase to every two years after 2011), the focus of WPC is now much more on promoting the link between plumbing, health and the environment. The simple message which I am keen to promote whenever the chance arises is that plumbing is important.

A year or so back, readers of the UK-based British Medical Journal were asked to nominate the most important medical advance of the last 150 years and we were delighted to learn that anesthetics, antibiotics and other more obvious medical advances were all beaten by the winner: sanitation. While it is encouraging to learn that British doctors at least understand the importance of this aspect of our industry, in reality, most citizens of

most developed countries have either forgotten or have never understood that plumbing is linked to public health.

Sadly, in 2009, there are many people in developing countries whose health is seriously compromised through the lack of acceptable drinking water or acceptable sanitation. The statistics are frightening. Every year millions of people (often children) die or suffer serious health issues because they do not have access to decent plumbing. What a difference a basic plumbing industry infrastructure would make, for example, in many sub-Saharan African countries!

#### Plumbing and Health

WPC has worked for over a decade with the World Health Organisation (WHO) to promote the role of plumb-



ing in the health aspects of water and sanitation, and we are pleased to report a number of significant milestones in this relationship including:

- The joint publication between WHO and WPC in 2006 of "Health Aspects of Plumbing"- an invaluable guide to the way in which good plumbing and good plumbing products could improve health conditions particularly in developing countries.
- The recognition of WPC as a Non-Governmental Organisation (NGO) in official relations with WHO in 2007 (and since renewed).
- The secondment of a plumbing professional on behalf of WPC to work for a year on plumbing related projects

within WHO. John McBride, from Australia, who undertook this role, undertook a number of activities, including developing a position paper on plumbing regulation

which is being shared with WHO's network of water regulators, and preparing a training package on the health aspects of plumbing (which is to be supported by a DVD presentation currently under development). Although the secondment was limited to one calendar year (2008), the work started during that year continues and there is no doubt that the WPC name and message is better understood within WHO and the agencies with which it works than ever before. WPC gratefully appreciates the financial support which it received from some of its members (including PMI), without which, this project could not have progressed.

#### The Green Agenda

Awareness of "green" issues is growing all over the world and the plumbing industry's role in such issues is enormous. That is why we are aiming to produce a companion volume under the (working) title of "Environmental Aspects of Plumbing," the first edition of which is due to be published on 11 March 2010 (more about the significance of that date on page 12).

WPC's current membership consists of a wide range of representative bodies (like PMI), which qualify for Full Membership and other organisations (including individual manufacturers) with an interest in plumbing (Affiliate Members). There are currently WPC members in some 23 countries representing over 50% of the world's population. The fact that we have members in India and China greatly helps the population coverage

His son, **Tim O'Keeffe**, will carry on the legacy that began with Tim's grandfather, **Paul C. Symmons**, the company's founder.

Bill was instrumental in the revitalization of PMI in 1998 and led the charge to find new leadership for the organization. In a classic presentation to PMI members, he characterized the four finalists in the field of 18 candidates for the post as: "a lawyer, a trade association professional, a plumbing industry professional and a woman." It was the woman that was ultimately hired!



Klaus married his wife, Barbara, in 1965 and he is the proud father of a son and a daughter, as well as the proud grandfather to his granddaughter. Although he says there isn't one person in particular that he considers the most influential person in his life, he says he has a great fondness for, "The various people I had contact with in my professional and personal life and the people I've gotten to know

Some provide customization that integrates with e-mail and mobile devices.
